

## **Bid document for the auctioning of earthmovers**

### **1. Background of the Organization:**

**Livolink Foundation** is a registered development organization under the Indian Trusts Act. The organization was registered in December 2010 and its head office is based at Bhubaneswar, Odisha. The main purpose of the organization is to facilitate technology-based livelihoods development and improve access to quality education in the underprivileged rural regions of the country.

### **2. Scope of Bidding:**

The Livolink foundation was engaged in earth works in Western Odisha for the augmentation of water resources to provide round the year water to the rural HHs, besides increasing water availability for irrigation to enhance farmers' income. To have smooth implementation of the project, the foundation had procured 6 earthmovers in the month of November 2017 and was used for the project works to excavation of earth for desilting ponds and improving their water harvesting capacity. As the project is now closed, there is no further scope of utilizing these machines and the foundation has decided to sell off these machines. The machine details such as the numbers of machines, types and model, number of hours run, year of purchase are mentioned in the section "List of assets".

The scope under this bidding process is limited to only the "selling of assets" listed in the section "List of assets", along with the required accessories and documents. There are no other assets of the foundation that would fall under this bidding process and thus no bidders should claim any other assets except the listed assets and its necessary accessories and documents mentioned here in the bid document.

### **3. TERMS AND CONDITIONS:**

- a) The intending tenderers are hereby advised to obtain the auctioned earthmovers list and tender the application form from Livolink Foundation office or by writing a request mail at [bid@livolink.in](mailto:bid@livolink.in). The earthmovers can be inspected in Bolangir city after prior intimation and coordination with Livolink Foundation before the submission of sealed tenders. Submission of the sealed tender will be considered as sufficient proof of the tender having been submitted after consideration of vehicles put up for sale in all aspects, and no further complaints regarding the condition of the vehicle will be

entertained in any circumstances. The auction sales of the earthmovers will be done on as-is where-is basis.

- b) The intending tenders will have to submit the Bid Security of Rs. 20,000/- (Twenty Thousand) only per earthmover in the form of Bank Draft/Bankers cheque in favor of Livolink Foundation, Bhubaneswar payable at Axis bank, Account no. 916010030550172, IFS Code – UTIB0003089, by filling bid as per the 'Bid application format' submitted in the sealed tender. Tender papers submitted without Bid Security Deposit in the shape of Bank Draft / Bankers cheque will be automatically rejected. Tenderers are encouraged to apply for all earthmovers by submitting bids separately for each machine as per the 'Bid application format' and submitting the bank draft/banker's cheque in favor of Livolink Foundation with cumulative amount of deposit in a separate sealed cover.
- c) All the tenders received will be opened in the presence of the tenderer or their authorized agents if they are present at **10 am on 27/07/2022 in the office of Livolink Foundation**. In case the date of tender gets declared as a Govt. Holiday, the tenders will be opened on the next working day at the same time. Livolink shall not be held accountable for any delay in postal delivery and the same shall not be taken as the ground for tender's consideration. The tender cover should be super scribed as "TENDER FOR EARTHMOVERS" along with the specification of the "NUMBER OF EARTHMOVERS".
- d) Selected tenders with highest offer of Bid amount shall be accepted and such tenderer shall have to deposit 5% of the accepted highest tender amount, after deducting the already paid bid security amount, immediately on the spot through the Bank Draft / Banker's Cheque and rest 95% also through the same means within 15 days from the date of issue of ratification order or confirmation of the tender. If the highest tenderer withdraws after the acceptance of their bid, the bid security amount previously deposited will be forfeited. This forfeiture shall be applicable even if tenderer has applied for more machines and the bid is accepted for fewer or one machine.
- e) In case the accepted highest tenderer fails to deposit the tender amount within the stipulated period from the date of ratification order/ confirmation of tender, 5% of the bid amount, including the bid security amount, deposited on the date of opening of the tender will be forfeited to Livolink Foundation and the vehicle will be put to resale entirely at the risk of the highest tenderer.
- f) The vehicles shall not be delivered to the highest tenderers till full payment is made and other formalities are fulfilled.
- g) The highest tenderer shall take the delivery and remove the vehicle from the spot within 15 days from the date of ratification of order/ confirmation of tenderer and full payment

of the highest tender amount, failing which no claim will be entertained under any circumstances and the custody and safety of the vehicle shall be the responsibility of the tenderer. Failure to remove the earthmovers within the time bar, ground rate at the rate 1% of the tendered amount will be charged for each day or part of the day, till the removal of the vehicle from the site.

- h) The transfer of ownership of the vehicles will be made only on the deposit of requisite fee and submission of proper application form and other required documents by the highest bidder.
- i) It is made clear that before the buyer picks up the Vehicles, all statutory documentation should be completed for ownership transfer. The Client shall not be responsible for any accident/ fraudulent or illegal use or misuse by the new owner and any implications arising out of it after the transfer of the Vehicle
- j) No one, except intending tenderers, or the authorized representative of the tenderers shall be allowed at the time of opening of seal tender.
- k) Tender Application form shall not be accepted after **5.30 pm** on **26/07/2022**.
- l) In case of any complaint/ objection or claim relating to the auction sale is raised, the decision of the undersigned shall be conclusive.
- m) Any dispute/litigation on the auction sale shall be subject to the jurisdiction of Bhubaneswar only. The undersigned reserve the right to accept or reject any or all the tenders without assigning any reason thereof.

### **AMENDMENT to the Bid document for the auctioning of machines by Livolink Foundation**

The existing point 3d in this tender document issued on 15<sup>th</sup> July 2022 is to be considered null and void. The same is amended to be read as -

The quotes in the bids opened will be submitted to the internal committee for decision making and the decision will be intimated to the tenderers within 30 working days through a written communication. The selected tenderer shall have to deposit 5% of the accepted tender amount, after deducting the already paid bid security amount, within two working days of the formal intimation of acceptance to the tenderer, through a Bank Draft / Banker's Cheque and the balance 95% also through the same means within 15 days from the date of issue of ratification order or confirmation of the tender. If the selected tenderer withdraws after the acceptance of their bid, the bid security amount previously deposited will be forfeited. This forfeiture shall be applicable even if tenderer has applied for more machines and the bid is accepted for fewer or one machine.
